**GENERAL BUSINESS:** 

◆ Bendigo Bank Grant. Bendigo Bank has allocated us a grant of \$1,000.00 of our requested \$7,500. As this falls a long way short of our hoped for funding do we wish to continue with the trailer project at this time?

Col, VK5HCF, informed the meeting that the grant application in the amount of \$7,500 has been approved but only for \$1,000.

After considerable discussion John, VK5DJ, <u>MOVED</u> that the Club purchase a new tandem trailer using club funds and the \$1,000 Bendigo Bank grant.

John's motion was seconded by Murray, VK5BWA, and the motion was carried.

Col, VK5HCF is to follow up on what happens next with Bendigo Bank.

John, VK5DJ made the suggestion that we consider selling Sponsor advertising space on the trailer to help defray costs.

- ◆ Peoples Choice Community Lottery. Peoples Choice Credit Union is running the Community Lottery again this year. Do we wish to participate as we have done in previous years. (It generated \$600.00 of income for us last year). Following some input from John, VK5DJ, Tim, VK5AV, MOVED that the South East Radio Group should be involved again in 2024. Tim's motion was seconded by Owen, VK5HOS and the motion was carried. Col, VK5HCF, to organise.
- ◆ Discuss the acquisition & purchase of all the Hillclimb video equipment from Andrew VK5KET.

Peter, VK5BE, outlined the details that have lead up to this. Over the years Andrew, VK5KET, has purchased,(or made), a lot of electronic gear, cables etc. to ensure that we were able to broadcast live video of the Hillclimb for the officials. He spent several thousand dollars of his own money, (and time), in doing so. With Andrews future plans in some doubt Peter and the executive committee decided to ask Andrew if he would sell this to the club to ensure that we can continue to provide the service regardless of Andrews future plans. Andrew has very generously agreed on the sum of \$2,000.00. After some comments from various members in the affirmative

Peter, VK5BE, with the support of the executive committee, <u>MOVED</u> that the South East Radio Group Inc. purchase all of Andrew, VK5KET's equipment for the agreed sum of \$2,000.00. Peter's motion was seconded by Tim, VK5AV and the motion was carried. Andrew, K5KET is going to provide a detailed list of what is involved.

- ◆ 2024 Convention. The Convention Committee has things well in hand and arrangements continue to slot into place. Sponsorship requests are being favourably received and members are fulfilling tasks as requested. The committee is holding regular online meetings and all is progressing well.
- ◆ The T.V. Hut upgrade is in hand and Nick, VK5NJS, is going to start painting the outside next Thursday. (25<sup>th</sup>). Other work is ongoing and all work is on schedule. Kate, VK5FKLY, has obtained a comfortable chair for the hut. Power points, circuit breakers etc. are currently being sourced. We have been advised not to purchase a second hand air conditioning unit. John, VK5DJ, offered to investigate the possibility of obtaining a unit at a very favourable cost. (\$0).

Peter, VK5BE, bought up the subject of a budget for the T.V. Hut upgrade.

He then **MOVED** that a total budget of \$1,000.00 be allocated for the upgrade of the T.V. Hut. (Excluding any cost for air conditioning).

Peter's motion was seconded by Maxwell, VK5AC, and the motion was carried.

- ◆ John, VK5DJ, informed the meeting that he has received an on-forwarded email from treasurer Andrew, VK5VKC, regarding the new self reporting laws for not for profit organisations. Treasurer and secretary to investigate this further.
- ◆ John, VK5DJ, informed the meeting that the club's Yaesu FT991 is now fully capable of remote operation. Peter, VK5BE, and Maxwell, VK5AC, went through the operation of it and showed the radio in use in conjunction with VK5DJ's home station. It works extremely well with HF coverage from 80 metres to ten metres plus 2 metres and 70 cm. A full description on

how to use it is on the club website. (Scroll down the index on the left hand side to "Recent Posts"

- ◆ John, VK5DJ, MOVED that the Club take out a twelve month subscription to the Server License, "Remote TX NET" at an annual cost of US\$70.00.
